

The following describes the terms on which B-Ventures, owned by DOCOMO Digital Italy S.p.A (here in after "DOCOMO Digital"), a company of NTT DOCOMO GROUP, offers you access to our site, services and programs.

#### **B-ventures Account**

In order to access some features of the Site or to participate to any B-Ventures program, you will have to create an account. You may never use another's account without permission. When creating your account, you must provide accurate and complete information. You must notify DOCOMO Digital immediately of any breach of security or unauthorized use of your account.
